

ULTRAFIBRE FIBRE UFB PRICE CAPS

This document, published and maintained by Crown Fibre Holdings Limited (CFH), sets out the Price Caps for Services offered by Ultrafast Fibre Limited (UFF) under its UFB Reference Offer. The Price Cap for a Service may not be the same as the Charge for that Service (although the Charges cannot exceed the Price Caps). Not all Services are subject to Price Caps.
